Deadline to respond to the call: February 28th, 2026

Since its very first edition, the GREDEG Ph.D. Workshop has been organized by Ph.D. candidates of the laboratory and is intended for all doctoral students affiliated with GREDEG. It provides an opportunity to present thesis work at any stage of progress, to engage in a moment of knowledge sharing, and to enrich the research presented.

The call is open to all Ph.D. candidates. First-year doctoral students may choose to present either their thesis project or more advanced work.

To respond to the call, please follow the submission guidelines below.

Submission guidelines:

The participant must submit a one-page abstract (no more, no less, no tables or graphs, and only few key references are allowed) ***before the deadline 28th February, 2026 (midnight)***. Applicants will be informed of the ***selection decision*** no later than ***March 15th, 2026***. Consequently, the deadline for submitting the ***final full paper*** is ***March 31st, 2026 (midnight)***.

The abstract should start with the title of your submission, followed by your name, your supervisor(s) name(s), your current Ph.D year, and e-mail address. This information is to come before the body of the abstract, which should be written in plain text (that is, without bullet-points or other special codes).

The abstract should focus on your research question and your own contribution. The abstract should mirror the full paper and could include following points:

1. Briefly describe the existing state-of-the-art and positioning of your contribution;
2. Explain the research gap that you are trying to fill and pose a research question;
3. Give your main theoretical arguments;
4. Spell out your method (and data, if an empirical paper);
5. Present your results and the contributions to the literature.

PS: We reserve the right to reject abstracts that do not comply with the above requirements.

Presentation format:

Each participant will have 10 minutes for their presentation, followed by 5 minutes for the discussant¹, and then 5 minutes of Questions & Answers with the audience.

(10min Presentation + 5min Discussant + 5min Q&A).

Presentation guidelines:

¹ A discussant is a researcher, ideally a specialist in the relevant field, who will provide an analysis of the presented paper and suggest avenues for improvement. The discussant may be external to GREDEG or to Université Côte d'Azur.

1. Presentations may be given in French or English. However, slides must be in English to facilitate understanding for all participants.
PS: The use of visual support is strongly recommended.
2. Doctoral presentations must be conducted **in person** (except in special cases). Moreover, although a hybrid format is planned, the presence of supervisors, discussants¹, and attendees is strongly encouraged.
3. **Discussants are mandatory** for all presentations.

Specific Guidelines for the Law Round Table:

A round table will bring together Ph.D. candidates in Law around a theme to be determined based on the participants' thesis topics.
